AGREEMENT BY PARENT(S) / GUARDIAN(S)

I / We declare that:

- All particulars provided on this form are true and correct.
- I / we accept responsibility for the full payment of school fees and understand that:
 - a) The annual school fees are compulsory, as agreed upon by the majority of parents at the annual budget meeting.
 - b) A first installment is payable on the first day of school, which is redeemed from the annual school fees.
 - c) The remainder of the school fees is payable in ten installments.
 - d) According to Article 39-40 of the Schools Act, all parties bound by this agreement will be held liable for the payment of mandatory school fees.
 - e) In the event of non-payment of the agreed upon school fees, Sand du Plessis High School reserves the right to take legal action, including for all expenses, legal fees, and interest charged with regards to the collection of the arrears amount.
 - f) I will apply for schoolfee exemption by 28 February if I am of the impression that I qualify.
- We agree to abide by the rules as stipulated in the code of conduct of the school, and to implement all amendments made to the code of conduct as well.
- We understand that although the school takes all necessary precautions to avoid damage / loss of learners' clothing and / or property, the school will not accept responsibility for such damage / loss.
- We agree to inform the school in writing should we decide to remove the learner, and to return all textbooks and equipment belonging to the school that may still be in the learner's possession.
- We undertake to ensure that should the learner be older than 15 years (compulsory school-going age), that he / she will attend school regularly, and only be absent for medical reasons.
